Applications are due June 1, 2014, to District Simplified Grants Chair Janet Mudd. Please access the Application form, Guidelines and Terms and Conditions for District Simplified Grants at rotary6080.org, moving your cursor over 'About District 6080' and then clicking on 'District Simplified Grants' under 'District and Club Resources.' Contact information for Janet is seen there also.

A listing of clubs qualified to participate has been provided and is available at the site, above. Maximum amount available for 1:1 match is shown. The grant must not necessarily meet the maximum, but 1:1 match is available up to that amount. Likewise, the club may choose to contribute more to the grant than the maximum match.

Reports from 2013-2014 District Simplified Grants were due April 15. Delinquent reporting jeopardizes a club's ability to receive future grants and also places in jeopardy the district's ability to receive its one District Block Grant for the year, from which District Simplified Grants are funded.





GSE INDIA TEAM MEMBERS SOUGHT

District 6080 is seeking applicants for the Group Study Exchange team to District 3132 in west central India. The GSE India team will visit District 3132 from early January to early February 2015, and a GSE team from that district will visit District 6080 during October 2014 and attend our District Conference. Applications are now being received from all those who want to be considered as team members. A GSE application is available at Rotary6080.org under Educational Programs. A copy of the *Group Study Exchange Program Guide* is also available at that site.

The purpose of the GSE program is to learn about life in the host country, including the vocational interests of team members, and foster peace and understanding. District 6080 will provide funding for round-trip transportation to the host district and back. GSE team members will stay in homes and travel with Rotarian hosts to various sites around the host district, learning about subjects of interest relating their work back home and their interests.

Applicants are expected to have vocations relating to one or more the Rotary areas of focus (peace and conflict prevention/resolution, disease prevention and treatment, water and sanitation, maternal and child health, basic education and literacy, and economic and community development). They must be employed full-time in a recognized business or profession for at least two years at the time of application. They must plan to remain in the workforce for a considerable time after the exchange so that the travel experience will have a significant impact on the applicant's career. Only those who are between the ages of 25 and 40, are U.S. citizens, and live or work in District 6080 may apply. Rotaract members are eligible to apply, but Rotarians and direct family members of Rotarians are not eligible.

If you know anyone in the 25-to-40 age group who might be qualified and interested in being considered for membership on the GSE India team, please tell him/her that a GSE application form is available at Rotary6080.org under Educational Programs. The completed application must be submitted to Brad Bodenhausen, Chair, District 6080 GSE Committee, 4321 S. Elmview Ave., Springfield, MO 65804, or send a scanned copy of the completed application to bradbodenhausen@missouristate.edu. The deadline for submitting a completed application is Sept. 2, 2014. 
